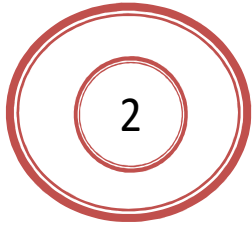

A person rendering valuation services without Certificate of Registration as a Registered Valuer can continue to offer their services till 31.01.2019, which was earlier 30.09.2018.</p> <p>2. A Person who was appointed for rendering valuation services and has not completed the same before 31.01.2019 (which was earlier 30.09.2018), shall complete the valuation within 3 months thereafter.</p> <p>3. Registered valuers organisation application can be given within 2 years from the commencement of this section (earlier it was one year)</p>

**STANDARD OPERATING PROCEDURE (SOP) FOR GRIEVANCE REDRESSAL MECHANISM COMPLAINT ON MCA WEBSITE**

through link <http://www.mca.gov.in/mcafoportal/userComplaintDetails.do>

1. Complaint should be raised by the stakeholders/ professionals.
2. A complaint number (ticket number) would be issued to the complainant and the complaint would be resolved within 3 working days.
3. If service complaints related to Name Reservation or Company Incorporation are not resolved to the satisfaction of the stakeholders, they may file appeal by sending an email to [grm.crc@mca.gov.in](mailto:grm.crc@mca.gov.in).
  - a. In the appeal, stakeholders should clearly mention in the subject, the ticket number along with the date on which the ticket was raised and the type of e-form. They should give details of the problem being faced by them.
4. The appeal will be decided by a committee headed by a Joint Secretary of MCA.
5. The stakeholder would also be informed about the decision of the committee.
